

## REQUEST FOR EXPRESSIONS OF INTEREST FOR PROVISION OF CONSULTING SERVICES (Firms Selection)

Subject	Feasibility Study and detailed Environment and Social Impact Assessment for the Improvement and Expansion of Water Supply and Sewerage Services to Chiredzi Town Council
Brief Description	Engagement of Consultants for Feasibility Study and detailed Environment and Social Impact Assessment ("ESIA") for the Improvement and Expansion of Water Supply and Sewerage Services to Chiredzi Town Council ("CTC")

- The Infrastructure Development Bank of Zimbabwe ("IDBZ/the Bank") intend to undertake the detailed feasibility study and the detailed Environment and Social Impact Assessment ("ESIA") for the Improvement and Expansion of Water Supply and Sewerage Services ("the Project") to Chiredzi Town Council ("CTC") to meet both the present and future demands for water supply and a) sewerage services.
- b) The project comprises a water supply & sanitation project, which shall be located in CTC. Chiredzi Town is located in the South Eastern part of the country in Masvingo Province, lying 203km from Masvingo town, the provincial capital.
- To meet the requirements of the National and UN Sustainable c) Development Goals for water and sewerage coverage for Chiredzi Town, two separate studies have to be prepared namely (i) A full Feasibility Study for the water supply and wastewater system, and (ii) Detailed ESIA including include gender analytical frameworks and mainstreaming. The detailed ESIA will include a detailed Environmental and Social Management Plan ("ESMP")
- (i) The Consultant shall analyze the technical, legal, financial, economic, environmental, and regulatory aspects of the Project. In undertaking the assignment, the Consultants shall also review all existing reports, studies and documentation regarding CTC. The work shall include but not limited to Assessment of the Demand, Water System, Sewerage System, the Consumption Records, Investment Plan, Legal Framework, Financial Performance, Economic and Financial Analysis, Climate Change, Cost analysis and Capacity Building.
- (ii) Additionally, the Consultant shall conduct an Environment and Social Impact Assessment (ESIA) study, including an Environmental and Social Management Plan (ESMP) as required in terms of the Environmental Management Act (Chapter 20:27) as read with Statutory Instrument 7 of 2007 (EIA and Ecosystems Protection Regulations) and in line with international best practices. The ESIA will include a gender impact assessment as part of the study
- d) The IDBZ now invites eligible National, Regional and International Consulting Firms to indicate their interest in providing the consultancy services for the detailed feasibility study which will include the technical analysis to ascertain technical viability, financial analysis, economic analysis, legal analysis, capacity building/institutional arrangements, cost estimates and detailed ESIA and ESMP. Interested Consulting Firms/consortia must provide information demonstrating that they are qualified to undertake this assignment individually or as a consortium i.e. provide Company profiles, Company registration documents, Curriculum Vitae, brochures, description of similar assignments; experience under similar environment or conditions; availability of appropriate skills/ experience among staff, etc. Prospective Consulting Firms may constitute joint-ventures where necessary to enhance their capacity to undertake the assignment.
- The main objectives of the ESIA will include, but not limited to conducting an environmental and social impact assessment study for the proposed project on the improvement and expansion of water supply and sewerage services to Chiredzi Town Council. This is required for the project to be implemented in an environmentally and socially sustainable manner, and in full compliance with both the Zimbabwe legal and regulatory requirements as well as international best practise standards applicable to water and sanitation projects.

The IDBZ now invites eligible Zimbabwean and Foreign Consulting Firms ("the Consultants") to indicate their interest by way of an Expression of Interest (EOI) in accordance with requirements stated herein in providing the services as specified in this document. Interested Consulting Firms should provide information demonstrating that they have the required experience, competences, skills, and qualifications relevant for performance of the services whether as individual firms, joint ventures or as consortia. The Consultants shall submit Company profiles, Company cogistration documents. Curriculum Vitage of keypersonal and professional registration documents, Curriculum Vitae of key personnel and professional staff, brochures, description of similar assignments, experience under similar environment or conditions. The Consulting Firm must demonstrate that they have fully established business offices. Prospective Consulting Firms may constitute joint-ventures where necessary to enhance their capacity to undertake the assignment.

## The minimum criteria for short-listing of the Firm shall entail:

- The Consulting Firm must be a registered entity and registered with the Procurement Regulatory Authority of Zimbabwe (PRAZ).
- A minimum of three (3) reference letters from traceable organisations must be submitted.
- Minimum of 10 years of experience for each individual consulting firm singularly or in the consortium in similar experience up to or at least five projects in the last 10 years.
- The following documents should also be submitted:
- detailed company profile;
- company registration documents;
- detailed curriculum vitaes of key personnel and professional staff (including certified educational certificates of the professional staff);
- proof of registration with PRAZ; and
- a summary the Firm's experience in similar assignments, together with the names and contact details of persons connected with these assignments who will provide references.

## Key personnel of the consultant firm should have the following minimum qualifications and experience:

- A Bachelor's degree in relevant discipline.
- Track record and demonstrable experience in conducting similar assignments
- The minimum years of experience for key personnel shall be 5 years iii. in the relevant field.

Short-listed Consultants will be invited to submit detailed technical and financial proposals, as described in Part 1 of the Request for Proposals Procedures in the Standard Request for Proposals for the Selection of Consultancy Services. The Consultant submitting the successful proposal will be engaged on the contractual terms set out in that document and in the General Conditions of Contract for Consultancy Services. Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications.

This opportunity is open to all Consultants who meet the criteria for eligibility as stated in Section 28 of the Act and who have the nationality of an eligible country as defined in Clause 1.10 of the General Conditions of Contract for Consultancy Services.

Bidders must accompany their expressions of interest with CR14 certificates as proof of Zimbabwean nationality and equivalent company registration documents for Foreign Firms.

Consulting Firms shall be required to pay an administration fee of USD100.00 for Zimbabwean Firms and USD200.00 for Foreign Firms to the Procurement Regulatory Authority of Zimbabwe's Special Procurement Oversight Committee for certain especially sensitive or especially valuable contracts for this tender in line with Section 54 of the Act as set out in Part IV of the Fifth Schedule to the Public Procurement and Disposal of Public Assets Regulations (SI 5 of 2018).

The IDBZ will reject an expression of interest if it determines that the consultant firm has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive or obstructive practices in competing for the Contract or been declared ineligible to be awarded a procurement contract under Section 99 of the Public Procurement and Disposal of Public Assets Act (PPDPA). An expression of interest shall be rejected in this procurement process if a Consulting Firm engages in anti-competitive practices including bidding in more than one expression of interest as a joint venture or consortium partner.

A Consultant may submit only one expression of interest. The expression of interest must be submitted in a clearly marked envelope and deposited in the tender box to the address below on or before 13 June 2019 by 1000hrs local time and clearly labelled "EOI Ref 31 of 2019: Feasibility Study and ESIA for the Improvement and Expansion of Water Supply and Sewerage Services to Chiredzi Town Council." Late expressions of interest will be rejected. Electronic submissions to the procurement e-mail below shall also be accepted and shall clearly be referenced as indicated above.
